## 10. Maintenance, Supplies Building and Property upkeep

- Hall renovation update: As of the date of these minutes the following table indicates work completed to date, work which remains to be completed and the current cost outlook. While the final projected cost is 10.2% above the \$465,000 approved at the Spring General Assembly meeting we are still within contingency limits.
- Currently the Hall Renovation Capital Campaign has raised \$204,174, of which \$150,000 is a singular donation from Nick and Katherine Sfikas.
- Funds have been transferred from the estate donations of the Carafos and \_\_\_\_\_\_ funds with an expectation to partially use the 2019 Greek Festival Funds.
