- Hall renovation update roofing in process, waiting for other final pricing; need to be mindful to complete process of outside costs
- Landscaping update-We spent more because of repairs needed; when we do the hall, we have to be more broadminded of costs; Phase I done; area with hydrangeas needs to be cleaned up and got estimate of \$2600.
- \$10,000 was donated from the estate of Irene Joglus and is being managed by her niece Mark Kritikos. Mary has indicated that these funds were set aside for landscaping. Alan met with Clover landscaping which the Joglus family has worked with and they will prepare proposal for the church.
- Alan informed us of the condition of the big tree in the front of the church. A Tree Pathologist was consulted with his diagnosis that the tree has been declining for several years and that the tree is now basically rotted from the inside and outside and is a potential safety hazard; Alan to get estimates on taking it down.
